

Post-it® Brand and Jonas Brothers Concert Giveaway Sweepstakes 2021 OFFICIAL RULES

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER, PARTICIPATE, OR WIN. A purchase does not improve your chances of winning. By entering the Sweepstakes, entrant fully and unconditionally agrees to and accepts these Official Rules. Open only to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older and the age of majority in applicable jurisdiction as of the date of entry and have a valid form of photo identification. Void where prohibited or restricted by law. All federal, state and local laws and regulations apply.

1. **PROMOTION PERIOD:** Post-it® Brand and Jonas Brothers Concert Giveaway (the “Sweepstakes”) begins at 12:01 a.m. Eastern Time (“ET”) on August 16, 2021 and ends at 11:59 p.m. ET on October 1, 2021 (the “Promotion Period”). Sponsor is the official time keeping device for the Sweepstakes.

2. **SPONSOR:** 3M Company, 3M Center, Building 0223-04S, St. Paul, MN 55144 (the “Sponsor”).

3. **ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older and the age of majority in applicable jurisdiction as of the date of entry and have a valid form of photo identification. Employees, directors, officers, agents, representatives and their immediate family members (including spouses, siblings, parents, children and their respective spouses) and household members (whether related or not) of Sponsor, Post-It Brands Company, E Group, Inc., Jonas Brothers, Jonas Brothers Touring LLC, and each of their respective parent companies, subsidiaries, distributors, sales representatives, affiliates and advertising and promotion agencies involved in design, implementation or execution of this Sweepstakes (together the “Promotional Parties”) are not eligible to enter or win. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void wherever prohibited or restricted by law. Entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes drawings. 4. **TO ENTER THE SWEEPSTAKES:** Online Entry Only: During the Promotion Period, you can enter the Sweepstakes at (post-it.com/jonasbrothers). To enter, you must provide your complete name, street address (no P.O. Boxes) city, state, zip code, e-mail address, plus day and evening telephone numbers. You will be requested to check off the box that you are 18 years of age or older and have a valid driver’s license. Entrants may only use one email address to register in the Sweepstakes. Once you have correctly registered, the confirmation of submission page will be displayed. A person may only enter the Sweepstakes once per day to get one entry into the drawing for the prize. You are not permitted to share the same email address account with another entrant. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will be void and your registrations and you will be disqualified. Use of any automated system to register is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected registrations, all of which will be ineligible to win a prize. In the event of a dispute as to any entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service

provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners of any prize may be required to show proof of being the authorized account holder to be awarded the prize. All registrations and entry information become the sole and exclusive property of Sponsor and will not be returned or cancelled.

5. **Limitations of Liability:** The Released Parties (defined below) are not responsible for: (a) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (b) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Sweepstakes; (d) technical or human error in the administration of the Sweepstakes or the processing of registrations; or (e) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. If for any reason an entrant's registration is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes. 6. **PRIZE DRAWING; ODDS OF WINNING:** Two (2) eligible Prize winners will be selected by random drawing from amongst all eligible entries received. The random drawing will be held on or about October 8th, 2021. An independent organization, whose decisions are final and binding on all entrants, will conduct the drawing. Winner will be notified by email or telephone. Odds of winning will depend upon the total number of eligible entries received.

PRIZE & APPROXIMATE RETAIL VALUE ("ARV"): Two (2) Prize Packages – Each Prize Package will include a VIP trip for two to The Jonas Brothers "Remember This" Tour concert event on October 27th, 2021. The trip includes two (2) round-trip economy class airfare tickets (chosen at Sponsor's sole discretion) from a major U.S. airport nearest to each individual's home, one night hotel accommodations (one room, double occupancy) at a Sponsor-specified hotel, one \$500 gift card for transportation, and two (2) concert tickets for the October 27th, 2021 Jonas Brothers concert event. All travel-related expenses not set forth herein, including but not limited to meals, ground transportation, parking, gratuities and incidental hotel expenses, are the sole responsibility of the winners. Winners must be able to attend concert event on the dates specified by Sponsor or the prize will be forfeited. Seat location shall be as determined by Sponsor in its sole discretion.
